Dear Parents:

It is time to begin registration for the 2022-2023 school year. We are aligning registration with *Catholic Schools Week*, beginning on **February 1, 2022**. Registrations provided to us by **February 28, 2022** will obtain a lower registration fee. We know that class size is important to you as parents. After registration forms are in on February 28, we will be able to determine the number of students registered in each grade and then determine the number of classes at each grade level. Registering by February 28 is important as there are no guarantees of space availability after that, including for current students. An important note relative to registration:

2022/23 registration will not be finalized until family is current with 2021/22 tuition as of January 31, 2022

The Parish Finance Committee has recommended increasing K-8 tuition for next school year by 4.0-5.2%, which ranges from \$160-\$180 per in-parish K-8 student depending on the number of children that are enrolled per family. The increase for preschool and pre-kindergarten will be 4.0-8.0%, depending on the number of children and grade level. These increases are based on a detailed analysis of the future cost of operating our school and targeted levels of the amount the church subsidizes the school. There will also be increases in registration and processing fees for the first time in years. Use of credit cards for both tuition and Before & After School Care program payments will be increased to more directly tie to our third-party expenses. Tuition levels will be contingent on parents reviewing and signing the new Tuition Subsidy Covenant included in the registration material.

As a means to help families budget for school tuition, tuition can be paid in full or over 10 or 12 months (9 months for Preschool 3 and Preschool 4). A tuition payment plan form is included with the registration packet that will allow parents to choose their payment option. Tuition payment booklets will be mailed to you if you choose to pay monthly. Paying the tuition in full by February 28, 2022 will waive the registration and processing fees.

We will continue to set aside some of each student's tuition to fund school technology (\$60 in 2022/23). With the continued advancement in technology, we plan to use the funds to better serve our students in the next school year, and for years to come.

If you would like to apply for St. John's financial assistance, you will need to apply online with FACTS Management. Your online application will need to be completed no later than **April 15, 2022**. Please see the enclosed sheet for more information. St. John's is committed to providing an excellent, faith-based education to our students. Our alumni consist of over 40 high school valedictorians and salutatorians, and, on average, over 90% of St. John students achieve honor status in high school. We offer a program for students identified as being cognitively gifted. St. John students consistently rank in the top 25% in the nation for academic performance on their standardized tests. We also benefit from partnering with OptimAll Learning and the Jon Peterson Scholarship to better meet the needs of our students with learning disabilities by staffing two intervention specialists, an occupational therapist, two speech- language pathologists, a Title I Reading teacher, a school psychologist and school counselor. St. John's is also an EdChoice Scholarship provider. We offer a Before and After Care Program for families in need of this service. We are continually seeking ways to improve our school programming and instruction. Our students participate in multiple community service activities by living the words of the Gospel.

We offer many after school extracurriculars for our students to participate in. Our Athletic program has a wide range of sports to choose from. We have a Fine Arts program as well as offering opportunities for students to participate in Student Council, Service Club, Art Club and many more! Registration forms without the registration fee payment will not be accepted. Registration fees will be waived if tuition is paid in full by February 28, 2022.

PROCESSING FEE FOR MONTHLY PAYMENT OF TUITION: \$60 (due with first payment)

REFUND OF THE REGISTRATION FEE:

The registration fee is non-refundable except in the following instances:

- 1. A family is moving out of parish.
- In the case of applicants for financial aid, if the amount of financial aid granted is not adequate, the family will have two weeks after notification of the aid to request a full refund.
- The class does not have adequate space for students.

Note: If a student is withdrawn and tuition has been paid in full without a registration fee paid, \$85 will be deducted from tuition refund.

CREDIT CARD USAGE: A 3% charge will occur on all tuition and Before & After School Care payments made using a credit or debit card. No fee will be charged for payments from a checking or savings account, nor will a fee be charged if a card is used for registration or processing fees.

FINANCIAL ASSISTANCE: St. John the Baptist financial assistance is only available for registered St. John's parishioners enrolled in our school in grades K-8. If you would like to apply for financial assistance, you will need to apply online with **FACTS Management**. Your online application will need to be completed no later than **April 15, 2022**. The link to apply online is https://online.factsmgt.com/signin/3XBQ9. The same application process is used to apply for aid from the Catholic Education Foundation, with the deadline for that program being February 6, 2022. A family who requests aid from St. Johns but does not apply in a timely fashion with the Catholic Education Foundation will risk receiving a lower level of aid from St. Johns. - 1. Late Fee: Tuition which is not paid by the first day of each month shall be assessed a late fee per late payment. The monthly late fee will be \$15 for accounts with a delinquent balance of under \$1,500 and \$30 for those accounts delinquent \$1,500 or more. If tuition is still delinquent at the time of registration for the next school year, the registration will not be finalized.
- **2. Tuition Reductions:** If Financial Assistance is awarded by the School or by the Catholic Education Foundation, then the Tuition described above will be adjusted proportionally in accordance with the payment plan chosen.
- **3. Credit Card Fee:** A 3% charge will occur on all Tuition and Before & After School Care payments made using a credit or debit card. If a credit card is used to pay the Registration or Processing Fees, there will be no charge for that credit card use.
- 4. Withdrawal: If a student is withdrawn prior to the start of the school year, a full tuition refund will be provided. If the student is withdrawn after school begins but before January 1, 2023, a 50% refund will be provided. If a student is withdrawn any time on or after January 1, 2023, no refund will occur. Registration or Processing Fees will not be refunded if a student is withdrawn after the school year begins (and only refunded prior to school starting in the instances outlined in the Tuition and Fee Schedule).

Tuition Subsidy Covenant

The Catholic Church has always recognized that the first teachers of their child(ren) in the ways of faith are parents. Statistics show that children who grow up in a family which regularly participates in the life of the parish are significantly more likely to continue to practice the faith as adults.

St. John the Baptist Parish School exists first and foremost to assist parents in the holistic formation of their children in the Catholic faith. Integral to life of the Catholic faith is physical attendance and participation in Sunday Mass in which we are drawn into the life of Christ more deeply by hearing the Word of God and sharing in the Eucharist. In fact, St. John the Baptist Parish is so committed to assisting parents in the faith development of children that the parish subsidizes 45% of the total tuition expense of each student. It is reasonable for those whose generosity provides this resource to expect that parents earnestly take this responsibility to actively live the faith, including regular participation in Sunday Mass as well as growing in the faith through participation in parish activities.

Parents who wish to receive the active parishioner tuition subsidy are expected to commit themselves to strive to attend Mass every Sunday (unless there is serious reason for missing it) and to participate in the life of the parish in other ways as they are able, in light of the commitment before God that they signed at preparation for marriage, orally promised when they married, and recommitted themselves to when their child was baptized to actively raise their child in the Catholic Faith.

Parents who wish to have their child(ren) attend St. John's without renewing their commitment to practicing the Catholic faith at home are welcome to send their child(ren) to our school, but do not qualify for the subsidy which is intended for families who make the commitment to raise their children in the Catholic faith. We rely on the integrity and honesty of those who apply for the subsidy to be faithful to the commitment they made in the past and renew for this year. We will not be recording attendance. One's commitment in the sight of God should suffice.

Dear Parents,

St. John's has been an EdChoice Scholarship provider for many years.

The EdChoice scholarship has been available since 2005 and expanded in 2013. It provides students from designated public schools who are deemed underperforming, the opportunity to attend participating chartered nonpublic schools. These are referred to as EdChoice Traditional Scholarships. The program expansion in 2013 provided low income students the same opportunity. These are referred to as EdChoice Expansion Scholarships. The scholarship pays up to \$5,500 for grades K-8. The student's resident public-school district funding supports the program. An appropriation in the state budget finances the expansion of the program to low income families.

Since none of the Southwest Local School District schools are currently on the list from ODE of underperforming schools; none of our new or current students are eligible for this scholarship. Although, new and current students are eligible for the EdChoice Expansion scholarship which is based on income.

The EdChoice Expansion scholarship allows for current and new students (Kindergarten-8th grade) of St. John's who qualify to apply for a tuition scholarship for the 2022-2023 school year. The initial income qualifications for 2022-2023 school have not been released yet, but they will be similar 2021-2022 guidelines. Below is the income qualification chart for the 2021-2022 school year. If you believe you qualify and/or have questions about the EdChoice Expansion scholarship for the 2022-2023 school year, please contact me. There is only a certain amount of funds set aside for this scholarship. There is no quarantee that a scholarship will be awarded. The application period begins February 1st.

ACTIVE PARISHIONER TUITION RATE POLICY

The four criteria (all of which must be met) for receiving the active parishioner reduced rate of tuition or financial assistance is:

1. Registration as a member of St. John the Baptist Parish in Harrison

2. Submitting baptismal certificate

Submitting a baptismal certificate from a Catholic Church or a certificate of full communion with the Catholic Church, with the application for the first year of attendance (unless child was baptized at St.John's, Harrison, Ohio)

3. Committing themselves to strive to attend Mass every Sunday

While the determination of active versus non-active status will not be measured by specific attendance at mass, all families are required to make a formal commitment to practice the Catholic faith by signing the Tuition Subsidy Covenant document included with the registration material.

4. Being as active in the life of the parish as possible

While this cannot be measured, it is expected that every family participate in parish events, either by offering time as a volunteer for individual or continuous activities and/or by participating in faith formation events in the parish.

5. Financially supporting the parish as best as you can afford.

There is not a set amount for this, nor does the parish assess each family; however, each family is expected to support the parish as best they can. The active parishioner tuition rate is dependent upon each family's financial support.

Tuition Assistance Application Information

FACTS Tuition Management will be conducting the financial need analysis for St. John the Baptist School families that are applying for tuition assistance for the upcoming 2022-2023 school year. Families applying for financial aid will need to complete an application online and submit the necessary supporting documentation to FACTS Grant & Aid Assessment by **April 15**, **2022**. Applications will only be processed when all supporting documents are received by FACTS. The program requires 2021 tax returns. Applicants can apply online with the FACTS link at https://online.factsmgt.com/signin/3XBQ9. If this is your first time applying for tuition assistance with FACTS, you will need to create a new account. There will be a \$35.00 fee to apply for tuition assistance that will need to be paid online to complete your application process. Families will be notified of tuition assistance awards by May 31, 2022.

Another source of potential financial aid is through the Archdiocese's Catholic Education Foundation, with the deadline for that program being February 6, 2022. This program requires only 2020 tax returns. A family who requests aid from St. John the Baptist but does not apply in a timely fashion with the Catholic Education Foundation will risk receiving a lower level of aid from St. Johns. More details about this aid can be found at www.CatholicBestChoice.org.

If you have applied for tuition assistance at one of the high schools in the Archdiocese of Cincinnati, you will only need to list your child's name that is attending our school on that application and submit your 2021 tax returns. There will be no additional fee to apply for tuition assistance for our school.

Financial assistance is only available for registered St. John the Baptist parishioners who have signed the Active Parishioner Tuition Subsidy document, with students enrolled in our school in grades K-8. Tuition assistance is not available for preschool or pre-Kindergarten students. Also, if a family receives funds from the EdChoice program, no additional financial aid will be needed.

All tuition assistance applications will be handled through an online application. If you do not have access to apply online, please contact our Business Manager, Mike Newton, mnewton@stjb.net or 513-367-9086 ext. 211.

Once an online application has been completed, the following information will need to be sent to FACTS to complete the application process:

- Copies of your 2021 Federal tax forms including all supporting tax schedules
- Copies of your 2021 W-2 forms for both you and your spouse
- Copies of supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and TANF

All supporting documentation can be uploaded online in pdf format.
